## A BILL

To amend section 308 of the Lewis and Clark Expedition Bicentennial Commemorative Coin Act to make certain clarifying and technical amendments.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Lewis and Clark Com-  
5       memorative Coin Correction Act”.

1 **SEC. 2. LEWIS AND CLARK COMMEMORATIVE COIN AMEND-**  
2 **MENTS.**

3 Section 308 of the Lewis and Clark Expedition Bi-  
4 centennial Commemorative Coin Act (31 U.S.C. 5112  
5 note) is amended—

6 (1) in subsection (a), by striking “Secretary as  
7 follows:” and all that follows through the end of the  
8 subsection and inserting the following: “Secretary  
9 for expenditure on activities associated with com-  
10 memorating the bicentennial of the Lewis and Clark  
11 Expedition, as follows:

12 “(1) NATIONAL COUNCIL OF THE LEWIS AND  
13 CLARK BICENTENNIAL.— $\frac{1}{2}$  to the National Council  
14 of the Lewis and Clark Bicentennial.

15 “(2) MISSOURI HISTORICAL SOCIETY.— $\frac{1}{2}$  to  
16 the Missouri Historical Society.”;

17 (2) by redesignating subsection (b) as sub-  
18 section (c); and

19 (3) by inserting after subsection (a) the fol-  
20 lowing new subsection:

21 “(b) TRANSFER OF UNEXPENDED FUNDS.—Any  
22 proceeds referred to in subsection (a) that were dispersed  
23 by the Secretary and remain unexpended by the National  
24 Council of the Lewis and Clark Bicentennial or the Mis-  
25 souri Historical Society as of June 30, 2007, shall be  
26 transferred to the Lewis and Clark Trail Heritage Foun-

1 dation for the purpose of establishing a trust for the stew-  
2 ardship of the Lewis and Clark National Historic Trail.”.
